Doc Benoit Recognized

During the 60th Anniversary Dr. Robert E. Benoit was recognized for his service to the fraternity. Woody Kessler presented Doc with a special resolution signed by Governor Ralph Northam. Doc received a standing ovation following Woody's reading of the resolution.

By virtue of the authority vested by the Constitution of Virginia in the Governor of the Commonwealth of Virginia, there is hereby officially recognized:

Robert E. Benoit, Ph.D.

WHEREAS, Robert E. Benoit, Ph.D. joined the Virginia Tech faculty in 1962, was inducted into Tech's Academy of Teaching Excellence in 2002 as he received the William E. Wine Award, and was also recognized by The Carnegie Foundation for the Advancement of Teaching as Virginia Professor of the Year; and

WHEREAS, Dr. Benoit served as pre-med advisor, mentoring the next generation of scientists who have become distinguished teachers, researchers, physicians, dentists, pharmacists, veterinarians, and other health professionals; and

WHEREAS, Dr. Benoit, joined Lambda lota Society, the University of Vermont's first Greek community, as an undergraduate, forming a lifelong passion for the role fraternities play in the positive development of young men; and

WHEREAS, "Doc" Benoit became faculty advisor to Sigma Omega Tau in 1965 and guided its transition to Lambda Chi Alpha, remaining a role model and advisor for 53 years, guiding over 500 brothers to become contributing members of their communities in Virginia and across the world;

NOW, THEREFORE, I Ralph S. Northam, do hereby recognize Robert E. Benoit for his outstanding leadership and commitment to the brothers of Sigma Omega Tau and Lambda Chi Alpha, thereby improving the lives of Virginia Tech students in the COMMONWEALTH OF VIRGINIA, and I call this observance to the attention of all our citizens.
